The mission of the Northern California Cancer Center can be stated in just two words: cancer prevention. Although it is simple to say, it is not simple to accomplish, especially as funding for cancer research has been declining now for five years. The consequences of under-funding are real. Research that could have taken us forward has not been conducted, and scientists starting careers have gone unsupported, reducing both the pipeline of research and the talent to do it.

Here at the Northern California Cancer Center, we applaud President Obama's call to a renewed commitment to funding cancer research, just as we embrace the mission to prevent cancer from occurring in the first place. We remain uniquely positioned to respond to this aspect of the work that must be done.

The NCCC specializes in cancer prevention through research that understands why cancer starts in the first place. Our studies determine why some people develop cancer while others do not, and they examine patterns of cancer across whole populations so that we can identify the groups most affected and most in need of help. The work of our committed scientists, educators and staff takes into consideration people's lifestyle choices, socio-economic factors, race, ethnicity, and genetics as we endeavor to determine why cancer develops and how to intervene to stop it before it starts. Our work encompasses all parts of the community, and we are dedicated to alleviating the inequities in who gets cancer and who has access to state-of-the-art diagnosis and treatment.



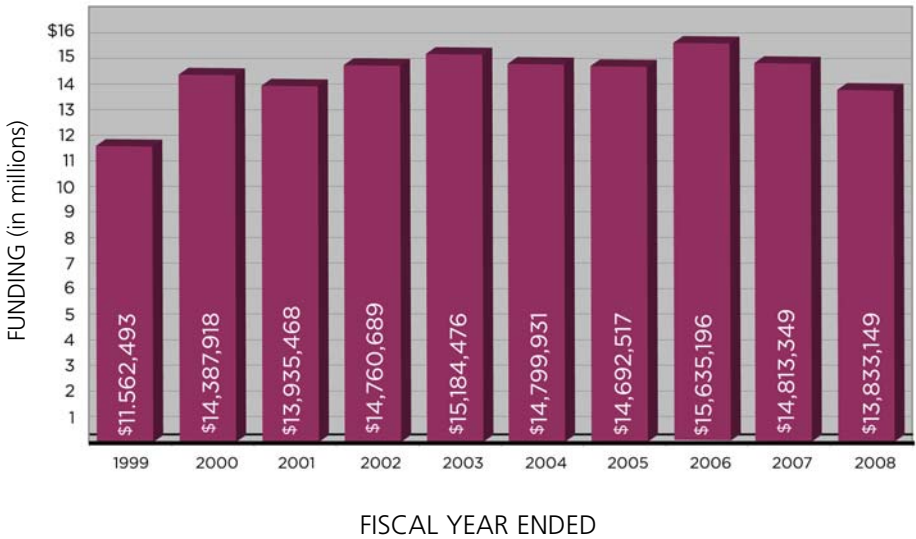
